USA SHOOTING GAMES STAFF SELECTION PROCEDURES 2023 PARAPAN GAMES June 12, 2023

These procedures provide for selection of USA Shooting's Games Staff for the 2023 ParaPan Games (the Games). However, accreditation allocation is not guaranteed and will be based on final USOPC credential allocation and overall team size. Responsibility of payment for allocated accreditations will be determined by the USOPC and the NGB.

1. List of specific Games Staff position(s) that USA Shooting is requesting:

Games Staff Role	Responsibility	
Team Leader	Serve as primary point of contact and liaison between the USOPC and USA Shooting before, during and after the Games.	
Coach	Prepare athletes/teams for success on the field of play.	
Medical Personnel (for example, ATC, Physio, Physician, Massage Therapist)	Provide appropriate medical care for the team.	
Administrative Personnel (e.g., Team Manager, Sport Psychologist, or other non- medical performance staff)	Provide on the ground coordination for athletes and coaches in tandem with Team Leader and Coaching staff.	
Team Support Staff focused on athlete accessibility needs (i.e., personal care assistants)	Provide customized support for athletes as required (i.e. supervision, wayfinding, help with everyday care and/or activities of daily living).	
Technical Personnel (e.g., Gun smith, Video Techs)	Provide services such as gunsmithing to ensure athlete performance.	

2. NGB's criteria for the above-listed Games Staff position(s):

All Games Staff must:

- 2.1. Undergo a background screen in accordance with the current <u>USOPC Games</u> <u>Background Check Policy & Procedures</u> prior to nomination.
 - 2.1.1. Should a nominee experience any event between the time the background check is conducted and the relevant Games that may change his/her background check status, the nominee must inform the NGB/PSO and/or the USOPC.
- 2.2. Possess a valid passport that does not expire until at least six months after the conclusion of the Games.
- 2.3. Have the ability to work effectively with the USOPC.
- 2.4. Have strong administrative, communication and organizational capabilities/skills as applicable for the Games Staff role.
- 2.5. Be responsible for Team's adherence to all rules regarding personal conduct at the Games.

- 2.6. Fulfill all duties and requirements of the USOPC including attendance at USOPC Games related meetings, as applicable.
- 2.7. Be available for entire duration of the Games, if requested.
- 2.8. Have NGB approval prior to making any financial decisions regarding the Team.
- 2.9. Possess high level, specific technical and tactical knowledge of the sport as needed for the Games Staff role.
- 2.10. Have thorough knowledge and understanding of the IF rules and regulations governing the sport as needed for the specific role.
- 2.11. Demonstrate ability to establish harmonious relationships with athletes and other Team personnel.
- 2.12. Be in good health and able to withstand the physical rigors of traveling with and working with the Team.
- 2.13. Be a currently employed staff member or contractor of the NGB.
- 2.14. Be listed on NGB's Long List.
- 2.15. Successfully complete all Games Registration requirements by stated deadlines.
- 2.16. Participate in the appropriate anti-doping training as required for the Games Staff role by stated deadline.
- 2.17. Successfully complete the appropriate U.S. Center for SafeSport's online training module(s) by stated deadline.

In addition, Team Leader must:

2.18. Possess appropriate experience of working with the USOPC in relation to Games Planning.

In addition, Coach(es) must:

- 2.19. Possess a high level of specific technical and tactical knowledge of the sport.
- 2.20. Have traveled with the Paralympic team athletes as a coach/loader previously.

In addition, Medical Personnel must:

- 2.21. Meet the minimum criteria defined in the <u>USOPC Sports Medicine Provider</u> <u>Credentialing Policy</u>.
- 2.22. Possess the appropriate professional certifications.
- 2.23. Pass a medical credential review in addition to the approved USOPC Games Background Check, <u>which will be a combined check managed through USOPC Sports</u> <u>Medicine (separately arranged background checks will not be considered)</u>.
- 2.24. Meet the required experience and proficiency levels as determined by USOPC Sports Medicine. (<u>https://www.teamusa.org/Team-USA-Athlete-Services/Medical/Sports-Medicine/Volunteer-Program</u>)
- 2.25. Complete the mandatory Games training prior to the Games.
- 2.26. Be approved for nomination through the USOPC's Sports Medicine Division.

- 2.27. Fulfill all requests and meet deadlines for any required information or documentation such as the submission of a temporary licensing application (to practice medicine at the Games) and medical equipment submission requirements.
- 2.28. Be familiar with and/or have worked with USA Shooting Athletes in past roles.

In addition, Administrative Personnel must:

- 2.29. Possess appropriate experience relative to the position/area of expertise for which they may be nominated.
- 2.30. Have traveled with USA Shooting athletes or staff in past roles.

In addition, Personal Care Assistants (PCA) must:

2.32 Have traveled with USA Shooting athlete before

In addition, Technical Personnel must:

2.31 Possess appropriate experience relative to the position/area of expertise for which they may be nominated.

In addition, Team Support Staff for athlete accessibility needs (i.e., personal care assistant) must:

- 2.32 Have sport specific expertise working with persons with disabilities.
- 2.33 Have experience working with athletes and coaches in a competition setting.
- 2.34 Be able to assist athletes/disability groups with daily personal care as necessary.

2.35 Assist with all aspects of the Team during travel, training, competition and downtime as needed.

2.36 Possess appropriate experience and/or professional certifications based on athlete(s) needs.

2.37 Additional criteria, if any, as determined by USA Shooting (e.g., have worked consistently in the role for the NGB/PSO at international competition during the current season).

3. Intended method of identifying the pool and selecting the candidates to be considered for the Games Staff position(s):

NGB/PSO will not solicit applications for the Games Staff position(s) listed above as they will be filled by current NGB/PSO employees and/or contractors.

4. Removal of Games Staff:

An individual who is nominated to the above-listed Games Staff position(s) by NGB/PSO may be removed as a nominee for any of the following reasons, as determined by NGB/PSO.

- 4.1. Voluntary withdrawal. Games Staff nominee must submit a written letter to the NGB/PSO Executive Director/CEO/President.
- 4.2. Injury or illness as certified by a physician (or medical staff) approved by the NGB/PSO. If the individual refuses verification of his/her illness or injury by a physician (or medical staff) approved by the NGB/PSO, his/her injury will be assumed to be disabling and he/she may be removed.
- 4.3. Inability to perform the duties required.
- 4.4. Violation of the NGB's/PSO's Code of Conduct <u>https://usashooting.org/resource-</u> <u>center/#category-code-of-conduct</u>
- 4.5. No longer able to meet the required criteria in Section 2 at the time of the Games.

Once the Games Staff nomination(s) is accepted by the USOPC, the USOPC has jurisdiction over the Games Staff, at which time, in addition to any applicable NGB/PSO Code of Conduct, the USOPC's Games Forms apply. The USOPC's Games Forms are available as part of Games Registration prior to the respective Games.

5. Replacement of Games Staff:

In the event that the Nominated Games Staff member is unable to perform the duties of the position(s) for injury, illness, Code of Conduct violation or any other unforeseen circumstances that would result in the need to replace him/her, the replacement candidate must meet all of the applicable criteria listed in Section 2 above.

6. Group/committee that will make the final approval of the Games Staff position(s):

7. Conflict of Interest:

All individuals involved in the selection process (see Section 6) must comply with the USA Shooting conflict of interest policy, to include completing and submitting a disclosure form for review by the NGB/PSO's Ethics Committee prior to beginning the selection process.

An individual involved in the selection process who has an actual, possible, or perceived conflict of interest must disclose it to the USA Shooting Ethics Committee prior to the start of the selection process. The NGB/PSO's Ethics Committee shall review the disclosure and determine the individual's level of involvement (e.g., whether he/she must recuse him or herself from the review process and/or voting).

Any recused individual shall be replaced in accordance with the NGB/PSO committee appointment process.

8. Date of Nomination:

Nominations of Games Staff, including the names of any replacements, will be submitted to the USOPC <u>on or before</u>: September 1, 2023

9. Publicity/Distribution of Procedures:

The USOPC approved selection procedures (complete and unaltered) will be posted/published by the NGB/PSO in the following location(s):

If the Athlete Representative reads and does not agree with the Selection Procedures being submitted by the NGB, he/she may submit those reasons in writing to his/her Sport Performance Team.

* If, for some reason, a sport does not have an elected USOPC AAC Representative, the NGB must designate an athlete from that sport to review and sign the Selection Procedures.
